



**Minutes of the Ordinary Parish Council Meeting

2021/102 Item 1 – To accept reasons for absence.

Councillor Appleton and Councillor Lister had submitted their apologies and reasons for absence. The reasons for absence were approved. Councillor Macefield took the Chair in the absence of Councillor Lister.

2021/103 Item 2 – Disclosures of Interest / Dispensations

No interest declared and no requests for dispensations were received by the Clerk in respect of this meeting.

2021/104 Item 3 – Minutes of previous meetings

Proposed by Councillor I Macefield

RESOLVED that the minutes of the meeting 3rd March 2021 were accepted as a true and accurate record.

2021/105 Item 4 – Planning Applications.

- a) **C/46/133G/LB - Listed building consent for erection of detached building to provide covered outdoor dining area and WC at Fox & Hounds, Chapel Lane, Starbottan, Skipton, North Yorkshire, BD23 5HY**

Resolved to support this application and to express the council's support for local business and efforts to increase customer safety.

- b) **C/46/19H - Full planning permission for change of use of residential property to include guest/B&B accommodation at Cleveliot House, Starbottan, Skipton, BD23 5HY**

Resolved to support this application on the grounds that it will support the local economy and benefit the community.

2021/106 Item 5 – Financial Matters

- a) **To confirm the Bank Account balance**

- c) **To appoint the internal auditor**

Resolved to appoint Clare Smith as internal auditor for the cost of £50.

Councillor Macefield suspended the agenda to enable Councillor Metcalfe to provide a report from Craven District Council. Councillor Metcalfe advised the council of the current consultation on the reorganisation of local government in

North Yorkshire. The consultation is available on line until the 19th April and the council agreed to encourage residents to take part by publicising the details on the website and social media.

2021/107 Item 6 – Defibrillator

To receive information about the defibrillator battery and consider any action required

The council was informed that the defibrillator in Starbotton requires a replacement battery. The current battery was purchased in October 2019 so should be within warranty. The clerk will contact the provider to request the battery be replaced.

Resolved to purchase a new battery if the old one cannot be replaced.

Further issues were identified with the cases of both defibrillators but it was agreed that any further action should be considered by the new council following the elections in May.

2021/108 Item 7 – Parish Council Meetings

a) To consider arrangements for the return to face to face meetings from the 7th May 2021

2021/109 Item 8 – Scarecrow Festival

The Scarecrow Festival Committee are currently conducting a consultation with residents to ascertain if the festival should go ahead in 2021 and in what format. The Council will consider appointing a councillor to the Scarecrow Festival Committee.

Resolved to encourage residents to take part in the current consultation by publicising it on the councils' website.

2021/111 Item 10 – Lighting Matters

The Council noted that there are still lighting issues which have not yet been resolved. Following elections in May the Council may need to consider employing a contractor to complete this work.

The Council recognise that the playground is a very valuable community facility and is keen to renew the lease if this is an option. Once a copy of the lease has been located this will be sent to the owner's land agent as requested in order to progress the issue.

It was acknowledged that the wayleaves have not yet been paid and that this should be resolved quickly.
